Marie Wilson – NHS legal highs (NPS) presentation.	<p>Marie Wilson came along to the meeting and gave a Presentation on NHS Legal Highs.</p> <p>Items discussed:</p> <ul style="list-style-type: none"> • Up to date knowledge • 779 respondents to drug survey in Ayrshire. • NPS - new psychoactive substances • Pilot in May – Prevalence work – Focus groups ADP • Injecting NPS (Ex heroin addicts) • Manufacturers are changing the chemical make-up of the drug. • Synthetic cannabanoids – East Ayrshire has problems with crack and synthetic canna. • Drug trend monitoring group – training and factsheet. • Become a virtual member of the group – prepare gather and share. • Recent increase in club drugs • Are we prepared? Do we know enough? • Methadrone – moonshine • Attitudes towards legal highs (NPS) have changed.
